

GENERAL PROVISIONS

1. The customer is obliged to read the terms and conditions and to accept them.
2. Tattoos can be applied to people who are at least 18 years old. There is also the possibility to tattoo minors (not less than 16 years old), but only with the consent signed in the studio by a parent or legal guardian.
3. The studio has the right to refuse tattooing without giving any reason.
4. The studio reserves the rights to the photographs, designs and tattoos
5. Please send any requests, complaints or claims exclusively to niepodrodzetattoo@gmail.com. Otherwise none of the requests will be considered.

RESERVATION OF AN APPOINTMENT / DEPOSIT

1. Reservation of an appointment can be made in person at the studio, by phone, email or through social media channels (FB, IG).
2. Initial reservations must be confirmed by payment of a deposit. The payment can be made in the studio or by bank transfer within 3 days of the date set. After 3 days, the reservation is cancelled.
3. The minimum amount of the deposit is 100 PLN.
4. The deposit is deducted from the final price of the tattoo service.
5. Paying the deposit is equal to accepting the regulations.
6. The deposit will be forfeited if the client doesn't come to the tattoo session date and doesn't inform the studio about the change of date.
7. The tattooist may change the date of a session if he/she considers that tattooing in a given session is impossible because of e.g. bad skin condition, changes on the client's body or in case of insufficient healing of the previous tattoo - in that case the deposit is transferred to the next session.
8. In special cases tattoo artists have the right to cancel a session - among others if the client is under the influence of drugs, alcohol or behaves in a dangerous way - in this case the deposit is forfeited.

PRICING OF TATTOO / SESSION

1. The studio doesn't have a price list of tattoos.
2. Each design is priced individually.

3. The minimum price is 200 PLN.
4. The price for a full day session is 1500 PLN.
5. A full day session lasts from 11am - 4pm/5pm.
6. Pricing is based on size, colour scheme and style. With complex designs the final price is spread over several full day sessions. The tattoo artist decides on the number of sessions.

TATTOO DESIGN

1. The design is prepared one day before the appointment at the earliest.
2. The studio doesn't send previously prepared designs.
3. Design is based on the information received from the Client.
4. We don't use designs from other artists - we work only on our own designs.
5. All designs and tattoos created by us are copyrighted. Duplication and copying by third parties is forbidden under the threat of civil law suits.

VISIT TO THE STUDIO / TATTOO TREATMENT

1. The studio doesn't provide treatment to persons under the influence of alcohol, drugs, psychoactive substances and narcotics.
2. Smoking and consumption of intoxicants is strictly forbidden in the studio.
3. The client is obliged to fill in the statement: "Consent for tattooing". The statement is available in the studio and must be filled in before the session. The client is obliged to inform the studio about any ailments and health conditions that may prevent the tattoo service on the appointed day.
4. The studio ensures sterility of the tools and materials used.
5. It is strictly forbidden to touch the objects used for tattooing.
6. It is forbidden to bring animals and children to the session.
7. The Client can come to the session with a maximum of one accompanying person.

INFORMATION AFTER THE TATTOO SESSION

1. After the tattoo session the client receives a tattoo care instruction - verbal and written.
2. Studio is not responsible for the Client's failure to follow the care instructions.
3. Any complaints after stating the non-observance of the tattoo care instruction will be rejected and the tattoo will be fixed for a fee.
4. In case of doubts related to the healing process, the Client can contact the studio at any time.
5. Possible amendments resulting from the necessity of refining the tattoo are reported up to 3 months from the date of the tattoo and are free of charge.
6. The studio has in its offer professional cosmetics for tattoo care.

VOUCHERS

1. The studio has in its offer vouchers for tattoos.
2. The voucher is valid for 6 months from the date of purchase. After this date there is an option to extend it to a year free of charge.
3. The minimum price of the voucher is 100 PLN.
4. Booking a session with a gift voucher is subject to the same rules as booking a date, but doesn't require a deposit.
5. It is possible to give the voucher to a person other than the one indicated on the voucher, however, this should be consulted with the studio in advance.
6. If the voucher is not used on time, it is lost.

GUESTSPOTS

1. The studio is not responsible if a tattoo is done by a guest tattoo artist.
2. In case of any amendments please contact directly the guest tattooist who applied the design.

FINAL PROVISIONS

1. The regulations are binding.

2. Studio is not responsible for personal arrangements with the tattooist that violate the rules.
